LEGACY OF DANCE ACADEMY – WAIVER AND RELEASE

I will indemnify and save the school harmless from and against any all liabilities, claims, losses, or expenses related to the aforesaid injury, loss or damage. In the event the school shall be made a party to any litigation thereto, I shall protect and hold the school harmless and shall pay all expenses and reasonable legal fees incurred by the school in connection with such litigation.

Legacy of Dance Academy - Fees and Policies

Payments can be made in full by cash or cheque. Cheques are made payable to: Legacy of Dance Academy

First Term Class Payment: Due upon registration (includes \$25 + HST non-refundable registration fee)

Second Term Class Payment: Post-dated cheque for December 1, 2018

Third Term Class Payment: Post-dated cheque for March 1, 2019

Performance Costume Deposit Payment: Post-dated cheque for Nov.1,2018 (\$58.00 incl. HST - balance due Spring 2019)

Cash payments must be received 2 weeks prior to the above payment dates. Cheque or cash payments made after deadlines are subject to a 15% late payment fee.

First Term payment including registration fees are non-refundable, even if student has not yet started taking a class.

Withdrawal Policy: The school must be notified in writing 14 days prior to the start of the next term to be eligible for a refund. A \$25 admin fee is charged to all withdrawals.

Once a term has begun, no refund will be issued for the remainder of term classes. Students are therefore encouraged to continue through to the end of the term.

*NSF cheques are subject to a \$25 charge. Only a certified replacement cheque or cash will be accepted.

DISCOUNTS / PROMOS

Early Registration Discount Register by June 20th 2018 and don't pay the registration fee. Regular sibling discounts apply, but cannot be combined with other promotions or discounts.

Early Payment Discount Yearly (2018/2019) payments made in full on or before July 20, 2018 receive a **5% discount**. (plus applicable taxes and registration fee). If enrolled in multiple classes, payment must be made in full and is non-refundable for promotion entitlement.

Multiple Class Discount Students taking a 2nd class will receive a 10% discount. A 3rd class will be discounted at 15%. A 4th class will be discounted at 20%. (discount applies to the lower priced class(es) and is applied per student only)

Sibling Discount The registration fee is waived for additional siblings registered.

All costumes are proudly custom made in Canada. At the time of registration a costume deposit of \$58.00 post-dated for Nov. 1, 2018 is required for each class. Costume fees range between \$60 and \$85 dollars per class per routine plus HST.

Costume balances are due early spring. You will be notified of the balance required to pay.

Please note: You must notify the school in writing on or before October 25, 2018 if a student will not be participating in the year end performance. This notification is also required to be eligible for a costume deposit refund.
